If you can't measure it, you can't improve it!

This applies to much of what we do as health care providers, including reducing fall risk. The Fall Risk Screening quality measure is a two-part measure:

- 1. Screen for risk of falling using a validated tool. (Measure)
- 2.Document a care plan for all patients at increased risk of falling. (Improvement Plan)

We do this every day. Are we using a validated tool & creating a care plan? Are we making the payer aware we are assessing this? Here are two ways to ensure the answer to both questions is YES:

YES1: Use a validated, standardized **tool** for every screen and document a care plan if positive. You have options!

- *Stay Independent Falls History
- *The TUG test
- *The 30-Second Chair Stand test
- *The 4-Stage Balance test

YES2: **Code** for your fall risk screen. CPT II codes to submit, whether it is part of a MCARE AWV or not, so the payer is aware and gives you credit for meeting the measure:

3288F Fall risk assessment documented AND

1101F Pt screened for fall risk and is not at increased risk of falling OR 1100F Pt screened for fall risk and is at increased risk of falling

Fall Risk Screening:

Potential Team Workflows

- Run a monthly list from EHR or Lightbeam of patients due for a welcome, initial, or subsequent annual wellness visit
- Call to schedule patients who are due for an annual wellness visit in the upcoming three months.
- When a patient is in clinic for an annual wellness visit, the clinical staff completes a fall risk assessment.
- Provider is made aware of risk, initiates, and documents a care plan AND follow up for those with moderate to high fall risk.
- Patient is scheduled for a follow up visit to specifically address fall risk.
- Provider documents a care plan appropriate for level of risk

Highlight a Champion

WHO: Firth Medical Center (FMC) Located in Firth, Idaho. Providers working at FMC include Katy Searle, FNP; Karla Hess, FNP; and Jacob Barney, FNP. FMC has been a part of PQA for five years. Katy Searle acquired FMC from Blackfoot Medical Center and the clinic has been serving the community for 8 years, as of August 1st, 2020. The clinic worked diligently with TCPi through AANP to achieve PCMH status and was also able to participate in the SHIP program in Idaho.

WHY: Did you know FMC has 88 Medicare patients, a total of 54% of their Medicare population, on their Chronic Care Management program? They have also completed 85 AWV's this year alone, which puts their year to date AWV rate at 52%.
